#### Participation in Proficiency Testing

Final report of the Proficiency Testing selected;

Microanalitica will provide notices and informations related to Proficiency Testing solely and exclusively to the personnel stated in the application form. Part of the material, excluding the unstable ones, will be available to customers for possible complaints and appeals up to 30 days from the pubblication of the final reports. Any issues relating to the final report of the proficiency testing must be received by Microanalitica within 30 working days from it's publication.
